Please note that passage of the Oregon Bar Examination is only one of the requirements necessary for admission to practice law in Oregon. An applicant may not practice in Oregon until the applicant is sworn in as a member of the Oregon State Bar.

Successful exam applicants will be sent a detailed packet of information including information on the admission ceremony, bar membership, bar number, the New Lawyer Mentoring Program and other relevant information. Successful exam applicants who have completed the MPRE and are eligible for admission may attend the admissions ceremony to be held on **Friday, May 2, 2014 at 1:30 p.m.** in Smith Auditorium on the Willamette University campus in Salem. Successful applicants who can not attend the ceremony may be sworn-in separately, though not before May 2. You may contact staff after April 18 for details.
